

### **Remote learning Policy**

## Remote Learning Homework:

Children will be expected to read daily at home using either: books sent home from school or accessing our online library (MyOn, AR reader KS2). Creative homework will be issued half termly via 'Google Classroom'. Pupils will be given homework linked to the current curriculum learning. The intent of the homework is to consolidate classroom learning and to extend learning beyond the classroom, giving children an opportunity to further challenge themselves. Children are encouraged to creatively showcase the knowledge and skills learned across their current topic. Pupils are encouraged to be independent and to attempt all homework set. The school understands the challenges associated with home learning and will support our parents and children in completing any tasks, where required. Parents will be informed as to when creative homework content will be

uploaded to 'Google Classroom' by their class teacher, via the school's text messaging service.

## Remote learning Individual absence:

In the event of a child being unable to attend school due to illness, the school will not be providing online work for that individual whilst they are off. However, if and individual is unable to attend school do to a COVID-19 related issue, work will be provided via 'Google Classroom' for those children. The work set will be of a similar content to what is being taught in class during that period. The deputy head teacher and class teachers will monitor all work uploaded to 'Google Classroom' and will give feedback where relevant.

# Remote learning: Closure of a bubble

In the unfortunate event that the school is required to close a 'Bubble', that 'Bubble' will be immediately transferred to daily remote learning via Google Classroom. However, the majority of lessons taught by the child's class teacher that are pre-recorded 'Zoom' style videos. The deputy head teacher and class teachers will monitor all work uploaded to 'Google Classroom' and will give feedback where relevant.
